- Current issues in immunisation
- Communicating with patients, parents and carers about vaccines
- Legal issues in immunisation
- · Storage and handling of vaccines
- Correct administration of vaccines and injection technique
- Anaphylaxis and adverse reactions (basic review) *full training required at your surgery.
- · Documentation, record keeping and reporting
- · Strategies for optimising immunisation uptake

The training includes:

- Certification
- Resources and the full program provided on a data stick
- Free Access to The online Global vaccination summit webinars
- Access to the facebook group supporting health professionals and parents in vaccine decisions.

On completion of immunisation training, the HCSW should only undertake immunisation if they feel competent to do so. This competence should be assessed and recorded, and each HCSW must be supported and supervised by a registered and experienced healthcare professional. Competency assessment, ongoing supervision, support and mentorship are seen as crucial in achieving clinical governance standards. In line with the national minimum standards and core curriculum for immunisation training of HCA's.
